3) Area Incidents / After Incident Reviews

Incident on the interstate in Bangor on the KD stream overpass, there were several vehicles involved in both lanes. Roads were icy which made it difficult to control approaching trafficking and to ensure safety. Attempted to divert traffic to the passing lane, and there was enough room but there was an issue with visibility. Salt trucks did eventually come through but not until the scene was better.

Lessons learned from this incident include that even though signs from Maine DOT were notifying travelers of the upcoming incident on the highway, it did not help as much as planned. Agencies were also on different channels, and if they had been on the same one,

secondary accidents could have been prevented. Many agencies were also backed up and although extra help was needed, there was no potential for extra support on that scene.
