2) Minutes from Hancock Meeting - June 11th, 2024 (Attachment A)

3) Area Incidents / After Incident Reviews

Bar Harbor expressed concern about not being warned about milling on Rt 3. DOT did not know the contractor was doing the work during the day and stopped it as soon as they found out. Better communication going forward is planned by both sides.

The Hancock Bike race After Action meetings resulted in race operators deciding to not come back next year and to potentially do an off-road race in 2026. This result comes as a result of the Hancock stakeholders not being in favor of the race coming back again unless massive changes to how the race is run occur.

Evening of September 10th, a wind farm transformer will be moved down Rt 1A and Rt 1 to Columbia. This will require several bridges to be closed temporarily so that the transformer is the only vehicle on the bridge. State Police are overseeing the move and will handle the traffic control but will cause some delays as it slowly moves along the road.

4) Outreach

BACTS is starting a group in rural Penobscot, Augusta, and Aroostook.

BACTS staff proposed attending meetings or gatherings of different agencies and disciplines (EMS Chief meeting, conferences, Fire or Sheriff association meetings) in order to share what TIMs is and why it matters.

5) Technology

BACTS Staff discussed the contracts that DOT has out to purchase more TIMs technology. Drones and message boards are a slower rollout but they are coming. Drones require someone to be trained before an agency can receive the device so that can make the rollout more difficult.

Communication upgrades to EMS vehicles are available for opt-in but that can result in more cost in future as agencies will need to pick up service costs after initial deployment subscription ends.

The suggestion was made that creating a list of agencies that want to pilot technology so that when items are available, agencies can be invited to attend the TIMs meeting. This would replace the system of giving it away to whoever happens to attend a meeting.

6) Construction Season

Rt 172 from Ellsworth to Surrey will start paving Week of September 9th Rt 3 on MDI from Jackson Lab to Otter Creek also will be mid-September Ellsworth to Orland between Bridge street and Rt 15

7) Training Updates

Bangor training in October and two Crash Responder Safety Week trainings

A topic also discussed was the issue of volunteer departments that can't send people to be training during the day. The counter suggestion of two hour night time sessions taught over two days or Saturday trainings in the fall/winter was mentioned.

Possible TIMs refresher training in the works from FHWA but timeline is very uncertain.

Potential online self-guided training desired by Steve Landry but may not occur soon
