3) IBI Work Update

IBI is working on an extension to the contract, continuing with state guidelines. They have created an updated presentation and write up for training. A rural training will be put together with an ETA around March. BACTS will be looking into a new FHWA TIMs refresher course to conduct refresher training for people who have already had TIMs training. FHWA will release update amendments and indices concerning new technologies and BACTS will distribute this material to TIMs groups

4) Training Materials Review / Update

BACTS will be looking into a new FHWA TIMs refresher course to conduct refresher training for people who have already had TIMs training. FHWA will release update amendments and indices concerning new technologies and BACTS will distribute this material to TIMs groups.

5) TIMs Self Assessment

The group was interested in resuming self assessments. BACTS staff will look into HWA self-assessments and attempt to figure out how they can be reimplemented.

6) Training Updates

BACTS' training goals for the year are to conduct at least six training sessions including an overdue training for the trainers since the last one was in 2018.

7) Review of Major Incidents

A tractor-trailer carrying diesel fuel overturned on Interstate 395 on the Wilson Street on-ramp and broke through guardrail resulting in a crash with a Penobscot County Sheriff's Office cruiser. The Officer and Truck driver were taken to the hospital with non life threatening injuries. The crash was possibly caused by the truck driver experiencing a medical event.

Discussed issues with communication between teams clearing accidents and teams responsible for safely redirecting traffic. Example was an incident where the crew responsible for redirecting traffic continued to redirect for three hours despite the scene being cleared. Another common miscommunications included calls for the wrong equipment or the lack of requests for equipment altogether.

Discussed the improper use of emergency lights by tow trucks, plow trucks, oversized loads, and other applicable emergency responders. Solutions included overhaul of Maine's laws, increasing enforcement, and improved training and technology.
